**NOTICE OF RELEASE OF  
SECURITY INTEREST IN TRADEMARK**

WHEREAS, by the Intellectual Property Security Agreement, dated as of April 16, 2013 (the “IP Security Agreement”), recorded in the United States Patent and Trademark Office at Reel/Frame 5008/0340, Cenveo Worldwide Limited, a Delaware corporation (the “Borrower”), as successor in interest to Cenveo Corporation (together with the Borrower, collectively, the “Grantors”), assigned to and granted to BANK OF AMERICA, N.A., as administrative agent and collateral agent (in such collective capacity, the “Administrative Agent”), a security interest in all right, title and interest of the applicable Grantor in and to, among other Collateral (as defined therein), the trademarks listed on Schedule A hereto (the “Released Intellectual Property”); and


WHEREAS, pursuant to that certain Confirmation of Partial Release, dated September 8, 2020, among the Administrative Agent and the Borrower, the Administrative Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of its security interest in the Released Intellectual Property.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the Administrative Agent hereby relinquishes, releases and discharges its security interest in all right, title and interest in and to the Released Intellectual Property, and hereby reassigns, grants and conveys to the applicable Grantor any and all of the Administrative Agent’s right, title and interest in and to such Released Intellectual Property. This Notice of Release of Security Interest in Trademark is applicable only with respect to the Released Intellectual Property and is not applicable to any other collateral assigned or granted under the IP Security Agreement (the “Retained Collateral”). The Administrative Agent retains all security interests, liens, rights, titles and interests pledged and granted to the Administrative Agent under the IP Security Agreement with respect to all such Retained Collateral, and the Administrative Agent’s security interest, liens, rights, titles and interests in such Retained Collateral shall not be impaired, interrupted or otherwise modified in any respect by this Notice of Release of Security Interest in Trademark.
