RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

WHEREAS, by a certain Amended and Restated Trademark Security Agreement (the “Agreement”; terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Agreement or in the Guaranty and Security Agreement referred to therein) dated as of June 9, 2015 by **SOUTHWEST STAINLESS, L.P.**, a Delaware limited partnership now known as Sunbelt Supply LP (the “Released Grantor”), in favor of **WELLS FARGO BANK, NATIONAL ASSOCIATION** (the “Agent”), which Agreement was recorded with the United States Patent and Trademark Office (the “USPTO”) on June 11, 2015 on reel 005550 frame 0885, the Released Grantor granted, assigned and pledged to the Agent a security interest in, all of its Trademark Collateral including the trademarks listed on Schedule I attached hereto; and

WHEREAS, Agent has agreed at the request of Released Grantor to release its security interest in the Trademark Collateral.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby (a) terminates, cancels and releases the Liens and security interests created under the Agreement in the Trademark Collateral, (b) releases its security interest in the Trademark Collateral and re-pledges, reassigns any and all interests it may have in the Trademark Collateral to Released Grantor, (c) discharges any and all rights, title and interest it has in and the security interest granted to the Agent in the Trademark Collateral, and (d) terminates the Agreement.
