RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS RELEASE dated as of October 1, 2020 (this “Release”) is made by WELLS FARGO BANK, NATIONAL ASSOCIATION, in its capacity as collateral agent (the “Collateral Agent”) under that certain Intellectual Property Security Agreement, dated as of April 5, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “IP Security Agreement”) by AM GENERAL LLC, a Delaware limited liability company (the “Grantor”) with an address of 105 North Niles Avenue, South Bend, IN 46617, in favor of the Collateral Agent. Capitalized terms not defined in this Release are used in this Release as defined in the IP Security Agreement.

WHEREAS, pursuant to the IP Security Agreement which was recorded (i) in the records of the United States Patent and Trademark Office on April 5, 2018 at reel 6308, frame 0380 and (ii) in the records of the United States Patent and Trademark Office on April 5, 2018 at reel 045443, frame 0534, the Grantor pledged and granted to the Collateral Agent a continuing security interest in, Lien on and a right of set off and recoupment against (the “Security Interest”) all of the Grantor’s right, title and interest in and to its then-owned or thereafter acquired Trademarks, Patents and Copyrights (and other Collateral), including those set forth on the attached Schedules A, B and C (collectively, the “IP Collateral”);

WHEREAS, the Obligations secured by the IP Collateral have been repaid or otherwise satisfied; and

WHEREAS, the Collateral Agent therefore is requested to release, terminate and discharge its Lien and continuing security interest in all of Grantor’s right, title and interest in, to and under the IP Collateral and the Grantor has requested and the Collateral Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office and the United States Copyright Office evidencing and effecting the release, relinquishment and discharge of its security interest in the IP Collateral (the “Released Collateral”) and termination of the IP Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the IP Security Agreement and the Security Interest created under the IP Security Agreement in the Released Collateral, (b) release its Security Interest in the Released Collateral, and (c) discharge any and all rights, title and interest it has in and the Security Interest granted to the Collateral Agent in the Released Collateral.
