**BETWEEN**

- (1) **LONG TALL SALLY LIMITED** (company number: 01240753) whose registered office is at Norwood House, 9 Dyke Road, Brighton, England BN1 3FE together with its group companies (i) **LONG TALL SALLY INC** (company number: 4795637) registered in Delaware, United States of America; (ii) **LTS TG LIMITED** (company number: 2214763) registered in Ontario, Canada; and (iii) **LONG FASHION GMBH** (company number: 48/740/02335) registered in Hamburg, Germany (together the "**Assignor**"); and
- (2) **AK RETAIL HOLDINGS LIMITED** (company number: 05150258) whose registered office is at Newcombe House, Bakewell Road, Orton Southgate, Peterborough, England PE2 6XU (the "**Assignee**").
- (3) **INTRODUCTION**
  - (A) This agreement is supplemental to the Asset Purchase Agreement relating to the business and assets of the Assignor dated 4 August 2020 (the "**Sale Agreement**").
  - (B) Under the Sale Agreement the Assignor has agreed to sell certain of its business assets to the Assignee.
  - (C) The Assignor owns the Assigned IPR (as defined below).
  - (D) The parties to this agreement have agreed that the Intellectual Property Rights (as defined below) in certain of those assets should be assigned on the following terms.

**AGREED TERMS**

**1. Definitions and interpretation**

1.1 Definitions

In this agreement, where the context so admits, the following words and expressions shall have the following meanings:

"**Assigned IPR**" means, collectively:

- (a) the Trade Marks, together with all the Assignor's goodwill associated with them including the **Business Name**;
- (b) the **Domain Names**;
- (c) Content of the **Social Media Accounts** operated by the Assignor; and
- (d) all other **Intellectual Property Rights** owned by the Assignor;

"**Business Name**" means "Long Tall Sally"

"**Designs**" means the design and manufacturing specifications for each Product on the list set out in part A of schedule 5 of the Sale Agreement.

**"Domain Names"** means all internet domain names, listed in the Schedule;

**"Intellectual Property Rights"** means patents, utility models, petty patents, supplementary protection certificates, trade and service marks, design rights (including unregistered UK and Community design rights in the Designs), trade names, service names, business names, copyrights, rights in the nature of copyright, geographic indications, resale rights, rental rights, lending rights, moral rights, database rights, domain names, semi-conductor topography rights, plant variety rights, rights in know-how, trade secrets and confidential information, rights protecting reputation and goodwill, rights in preventing unfair competition and all other intellectual property rights and analogous rights as may exist anywhere in the world for the full term of the rights concerned together with all reversions, revivals, extensions and renewals of such rights (whether registered or not); all registrations and pending registrations relating to any such rights, the benefit of any pending applications for any such registrations and the right to apply for registrations of such rights; and all rights of action, powers or benefits belonging or accrued in relation to such rights (including the right to sue for and recover damages for past infringements);

**"Moral Rights"** means any and all moral or similar rights vested in an author and/or his or her heirs and successors pursuant to any laws now or in future in force in any country in the world, including those rights conferred by Part I of Chapter IV of the Copyright, Designs and Patents Act 1988;

**"Social Media Accounts"** means those accounts operated under the handles listed in the Schedule; and

**"Trade Marks"** means all trade marks and service marks (whether registered or unregistered) listed in the Schedule.

## 1.2 Interpretation

In this agreement (including the introduction and schedules) unless the context otherwise requires:

- (a) clause headings are for convenience only and shall not affect the construction of this agreement;
- (b) reference to **"including"** or any similar terms in this agreement shall be treated as being by way of example and shall not limit the general applicability of any preceding words; and
- (c) reference to any legislation shall be to that legislation as amended, extended or re-enacted from time to time and to any subordinate provision made under that legislation.

## 2. Assignment

2.1 In consideration of payment by the Assignee to the Assignor of the sum of £1, receipt and sufficiency of which are expressly acknowledged, the Assignor hereby assigns to the Assignee, with full title guarantee, all rights, title and interest in and to the Assigned IPR, absolutely.

2.2 To the fullest extent permitted by applicable law, the Assignor irrevocably and unconditionally waives, or shall procure the irrevocable and unconditional waiver, in

favour of the Assignee of any and all Moral Rights in relation to the works comprised with the Assigned IPR.

### **3. Transfer of registered Trade Marks, Domain Names, and Social Media Accounts**

3.1 The Assignor will:

- (a) within 7 days of the execution of this agreement, complete the formalities required to transfer to the Assignee the Domain Names and such of the Trade Marks as are registered, or the subject of an application for registration, with any intellectual property registry, or other competent authority, anywhere in the world and to cause the Assignee to be duly registered as the registrant in respect of the same, including, in particular, completing any transfer documents (whether online or in written form) and providing any applicable confirmatory documents required by the relevant registrars' procedures; and
- (b) promptly do all other acts required to effect the foregoing transfer as soon as is reasonably practical and keep the Assignee informed of the progress of the transfer.

3.2 On execution of this agreement the Assignor will provide to the Assignee the passwords to the Social Media Accounts operated under the handles listed in the schedule.

3.3 Payment of registry and domain registrar fees incurred as a result of the recordal of this Assignment shall be the sole responsibility of the Assignee.

### **4. Further assurance**

4.1 The Assignor agrees to execute, sign and do all such further instruments, applications, documents, acts and things and give any further assistance (all at the reasonable expense of the Assignee, save to the extent that the request results from any failure by the Assignor to transfer the Assigned IPR in accordance with clause 2 or a breach of any warranty or obligation in the Sale Agreement or this agreement) as the Assignee may at any time reasonably request, properly to secure the vesting in the Assignee absolutely of the full right, title and interest in and to the Assigned IPR.

4.2 The Assignor hereby irrevocably appoints the Assignee and its successors in title and each of them to be its attorney to execute or sign any documents and do any other acts, matters and things which the Assignee may consider necessary or desirable for the purpose of carrying out or in any way giving effect to this clause 4 and the Assignor hereby ratifies whatever the Assignor shall lawfully do in pursuance of this clause 4.

### **5. General**



5.1 If at any time any term or provision in this agreement shall be held to be illegal, invalid or unenforceable, in whole or in part, under any rule of law or enactment, such term or provision or part shall to that extent be deemed not to form part of this agreement, but the enforceability of the remainder of this agreement shall not be affected.



5.2 As between the Assignor and the Assignee, nothing in this agreement shall limit, vary or derogate from the terms of the Sale Agreement.



- 5.3 Unless the right of enforcement is expressly granted, it is not intended that any provision of this agreement shall be enforceable by virtue of the Contracts (Rights of Third Parties) Act 1999 by any person who is not a party to this agreement.
- 5.4 This agreement and the Sale Agreement constitute the entire understanding between the parties relating to the subject-matter of this agreement and, save where expressly referred to, shall supersede all prior representations, writings, negotiations or understandings between the parties in relation to the Assigned IPR, except in respect of any fraudulent misrepresentation made by either party.
- 5.5 This agreement (and any dispute or claim relating to it, its enforceability or its termination) is to be governed by and construed in accordance with the law of England and Wales.
- 5.6 The parties submit to the exclusive jurisdiction of England and Wales in relation to any dispute concerning this agreement, but the Assignee is also entitled to apply to any court worldwide for injunctive and other remedies in order to protect or enforce its Intellectual Property Rights.
- 5.7 This agreement may be executed in any number of counterparts, each of which, when executed and delivered, is an original, but all the counterparts taken together shall constitute one document. This agreement shall not take effect until it has been executed by both parties.
