RELEASE OF TRADEMARK SECURITY INTEREST

This Release of Trademark Security Interest (“Release”) is dated effective October 23, 2020 by Exmarq Capital Partners, Inc. (the “Secured Party”), to Harrell’s Car Wash Systems, Inc., a Wisconsin corporation, as follows:

WHEREAS, Debtor and the Secured Party are parties to that certain Amended and Restated Security Agreement dated July 3, 2017 and that certain Notice of Grant of Security Interest in Trademarks dated April 30, 2019 (collectively, the “Security Agreement”);

WHEREAS, pursuant to said Security Agreement, Debtor granted to the Secured Party, for the benefit of the Lenders, among other collateral, a continuing security interest in all of the Debtor’s right, title and interest, including goodwill, in, to and under its United States trademark listed on the attached Schedule A (the “Trademarks”);

WHEREAS, evidence of the Security Agreement was recorded in the United States Patent and Trademark Office on May 3, 2019, at reel/frame 006636/0396;


WHEREAS, the Secured Party wishes to release its security interest in the Trademark listed on Schedule A only and retransfer and reassign to the Debtor without recourse all of the Secured Party’s right, title and interest in and to the Trademark listed on Schedule A.

NOW THEREFORE, the Secured Party hereby releases any security interest it may have in the Trademark listed on Schedule A, and reassigns any and all right, title and interest, including all goodwill associated with the Trademark, it may have in and to the Trademark listed on Schedule A without recourse to the Debtor.
