**RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of October 22, 2020, is made by PNC Bank, National Association (“Agent”) as administrative agent for various financial institutions (“Lenders”) in favor of Brightstar Corp., a Delaware corporation and Brightstar Device Protection, LLC (each, a “Grantor” and collectively, the “Grantors”). Capitalized terms used but not defined herein have the respective meanings given to them, directly or by reference, in the Trademark Security Agreement (as defined below).

WHEREAS, the Grantors were obligated to PNC Bank, National Association, Lenders and Agent pursuant to (i) that certain Sixth Amended and Restated Revolving Credit and Security Agreement, dated as of November 30, 2017, among Agent, Lenders, Brightstar Corp., Brightstar US, Inc., Offwire, Inc. and certain affiliates thereof from time to time a party thereto and (ii) that certain Trademark Collateral Security Agreement, dated as of December 19, 2017, made by the Grantors in favor of Agent (as each had been and may have been further amended, modified, restated or supplemented from time to time, collectively, the “Agreements”), and that certain Trademark Assignment of Security Interest dated as of January 3, 2018 (the “Trademark Security Agreement”), which was recorded with the United States Patent and Trademark Office on January 8, 2018 at Reel/Frame No. 6245/0185;

WHEREAS, pursuant to the Agreements and the Trademark Security Agreement, the Grantors assigned unto and granted to Agent for its benefit and for the ratable benefit of Lenders a security interest in and to the Marks, including the Marks listed on Schedule A hereto, together with the goodwill of the business symbolized thereby, and registrations and applications therefor (collectively, the “Trademark Collateral”); and

WHEREAS, the Grantors have requested that Agent terminate and release its security interest in and to the Trademark Collateral, including the Marks listed on Schedule A hereto;


NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby, without any representation and warranty and without any recourse to Agent, terminates, cancels, relinquishes, releases and discharges all security interests it has in or to the Trademark Collateral, and hereby re-assigns to the applicable Grantor any right, title or interest it may have in and to the Trademark Collateral of such Grantor.

Each Grantor (and any successor to such Grantor, as applicable, including any person or entity hereafter holding any right, title or interest in or to the Trademark Collateral of such Grantor) is hereby authorized to record this Release with the United States Patent and Trademark Office.
