RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of October 29, 2020 ("Effective Date") by Joseph J. Kulunas, as Personal Representative of the Estate of Norton J. Sky Cooper ("Grantee"), in favor of Chatam International Incorporated, a Delaware corporation (the "Grantor").

WHEREAS, pursuant to the Security Agreement dated July 16, 2008, executed by the Grantor in favor of the Grantee (the "Security Agreement"), which was recorded with the United States Patent and Trademark Office at Reel 003874, Frame 0162, the Grantee was granted a security interest in all of the Grantor's right, title, and interest in and to certain trademarks, as set forth on Schedule A attached hereto (the "Trademark Collateral"); and

WHEREAS, in connection with the execution of the Settlement Agreement dated October 27, 2020 (the "Settlement Agreement"), the Grantor has requested that the Grantee release the security interest in the Trademark Collateral, and the Grantee has agreed to do so.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Grantee hereby: (a) fully releases the Grantor and its successors and assigns from any and all obligations set forth in the Security Agreement; (b) fully releases and discharges the Trademark Collateral from the effect and operation of the Security Agreement; (c) terminates the security interest in the Trademark Collateral granted pursuant to the Security Agreement; and (d) acknowledges that all such interests are hereby reassigned to the Grantor. The Grantee hereby grants the Grantor the right to file all documents with the USPTO as may be necessary to accomplish the foregoing on behalf of the Grantee.



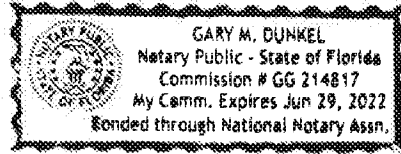
