**THIS ASSIGNMENT AND TRANSFER AGREEMENT** (this "Agreement") is made on 30<sup>th</sup> April 2020 (the "Effective Date").

**BETWEEN:**

**RENAISSANCE BIOSCIENCE CORP.** a corporation organized and existing under the laws of British Columbia with its head office at 410-2389 Health Science Mall, Vancouver, BC, V6T 1Z3 herein acting and represented by its chief executive officer John Husnik duly authorized for the purpose hereof

and

**RENAISSANCE YEAST INC.** a corporation organized and existing under the laws of British Columbia with its head office at 410-2389 Health Science Mall, Vancouver, BC V6T 1Z3 herein acting and represented by its chief executive officer John Husnik duly authorized for the purpose hereof

and

**BRIGHT BREWERS YEAST INC.** a corporation organized and existing under the laws of British Columbia with its head office at 410-2389 Health Science Mall, Vancouver, BC, V6T 1Z3 herein acting and represented by its chief executive officer John Husnik duly authorized for the purpose hereof

(collectively, the "ASSIGNOR")

and

**DANSTAR FERMENT AG.** a corporation organized and existing under the laws of Switzerland having its head office at Poststrasse 30, 6300 Zug (registration number CHE-101.456.260) and a subsidiary of Lallemand Inc. having a place of business at 1620 rue Préfontaine, Montreal, QC H1W 2N8 Canada and its head office at 151 Skyway Ave, Rexdale, Ontario, Canada, M9W 4Z5, herein acting and represented by Jean-Claude Villettaz its managing director (the "ASSIGNEE")

ASSIGNOR and ASSIGNEE, together the "Parties" and individually a "Party".

**BACKGROUND**

Concurrently with the signature of this Agreement the Parties have entered into a Master License Agreement (the "MLA").

The Assignor is the proprietor of record of the trademarks listed in Exhibit 1 (the "TMs") which are associated with the assets being licensed under the MLA.

Pursuant to the terms of the MLA, the Assignor has agreed to assign and transfer to the Assignee all the Assignor's right, title and interest in and to the TMs, effective as of Effective Date.

NOW THEREFORE, in consideration of the above recitals and the mutual covenants contained herein, ASSIGNOR and ASSIGNEE intending to be legally bound, hereby AGREE AS FOLLOWS:



## 1. ASSIGNMENT

- 1.1 In consideration of covenants and agreements and other good and valuable consideration granted under the MLA, receipt of which is hereby acknowledged by the Assignor, the Assignor assigns and transfers to the Assignee:
- a) all of the Assignor's right, title and interest it has in and to the TMs, without any assignment and transfer of any goodwill of the business connected with the use of, and symbolized by, the TMs or goods and services in association with which they have been used; and
  - b) all right, title and interest it has in and all causes of action and enforcement rights, whether currently pending, filed, or otherwise, for the TMs, including without limitation all rights to pursue damages, injunctive relief and other remedies for past, current and future infringement of the TMs.
- 1.2 The assignment is effective as of the Effective Date.

## 2. FURTHER ASSURANCE

- 2.1 The TM have been registered with the relevant authorities and Assignor is not aware of any facts, matters or circumstances (including any adverse legal opinion or communication from any relevant authority in any jurisdiction) as a result of which any such registration or application may need to be withdrawn, resubmitted, extended or amended.
- 2.2 The Assignor represents and warrants that, as of the Effective Date, there are no actions, suits or claims pending against Assignor challenging Assignor's ownership or control of the TM.
- 2.3 Assignor undertakes to perform any and all acts as reasonably required to have this assignment and transfer registered by the relevant authorities in the different countries where the TMs have been registered or applied for and for further assuring the complete and total right, title and interest of the Assignee in and to the TM.

## 3. MISCELLANEOUS

- 3.1 This Agreement shall be subject to the same provisions of governing law as provided in the MLA.
- 3.2 This assignment may be executed in one or more counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same agreement as at the date of signature of the Party last signing one of the counterparts. The exchange of copies of this Agreement and of signature pages by facsimile transmission or by electronic mail in "portable document format" (".pdf" format), shall constitute effective execution and delivery of this Agreement as to the Parties and may be used in lieu of an original Agreement for all purposes.






