**TERMINATION AND RELEASE OF SECURITY INTEREST IN
PATENTS AND TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS dated as of October 30, 2020 (this “*Release*”), is made by CRG SERVICING LLC, a Delaware limited liability company, as administrative agent and collateral agent (in such capacities, together with its successors and assigns, the “*Administrative Agent*”), in favor of SPECIALISTS ON CALL, INC., a Delaware corporation (“*Company*”).

WHEREAS, pursuant to that certain Security Agreement, dated as of June 17, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the “*Security Agreement*”), by and among the Company and Administrative Agent, the Company granted in favor of Secured Parties a lien on substantially all of its personal property, including without limitation the patents and patent applications listed on Schedule A hereto, and the trademarks and trademark applications listed on Schedule B hereto.

WHEREAS, pursuant to the Security Agreement, the Company executed and delivered to Administrative Agent the Patent and Trademark Security Agreement dated as of June 17, 2016, which was recorded against patents at the United States Patent and Trademark Office (“*USPTO*”) on June 22, 2016, at Reel 038987 Frame 0589.

WHEREAS, pursuant to the Security Agreement, the Company executed and delivered to Administrative Agent the Patent and Trademark Security Agreement dated as of June 17, 2016, which was recorded against trademarks at the USPTO on June 22, 2016, at Reel 5818 Frame 0917.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent and Company agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement.

SECTION 2. Termination and Release. Administrative Agent, without representation, warranty, or recourse, hereby:

- (a) terminates, cancels, discharges, and releases the security interest in all of the Company’s right, title, and interest in, to and under all of the following:
 - (i) all patents and patent applications, in each case whether now owned by Company or hereafter acquired and whether now existing or hereafter coming into existence, including without limitation those listed on Schedule A hereto, and all related patents and applications thereto, including all reissuances, continuations, continuations-in-part, revisions, extensions, re-examinations thereof, any patents and patent applications claiming priority to said patents and patent applications or from which said patents and patent applications claim priority, and pending applications associated therewith; and
 - (ii) all of the trademarks, whether now owned or at any time hereafter acquired, of Company that are registered with, or for which applications for registration have been filed with, the USPTO, including the trademarks listed on Schedule B hereto, and all registrations and pending applications associated therewith.

- (b) authorizes the recordation of this Release with the USPTO at Company’s expense.

SECTION 3. Choice of Law. This Release and the rights and obligations of the parties hereunder shall be governed by, and construed in accordance with, the law of the State of New York, without regard to principles of conflicts of laws that would result in the application of the laws of any other jurisdiction; *provided that* Section 5-1401 of the New York General Obligations Law shall apply.
