**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is made as of October 30, 2020 (“Effective Date”) executed by CIT Bank, N.A., in its capacity as administrative agent (“Agent”) on behalf of the Secured Parties, in favor of St. Croix Hospice, LLC, a Minnesota limited liability company (the “Grantor”). Capitalized terms used herein without definition shall have the meanings assigned to them in the Security Agreement (defined below).

**WHEREAS**, pursuant to the terms and conditions of that certain First Lien Security and Pledge Agreement dated as of September 29, 2017 (as the same has been amended, modified, extended or restated from time to time prior to the date hereof, the “Security Agreement”), the Grantor granted to Agent, for the benefit of the Secured Parties, a continuing security interest in and to, and lien upon (the “Trademark Security Interest”), all of the Grantor’s right, title and interest in, among other things, the trademarks and trademark applications listed on Schedule I attached hereto (the “Specified Trademark Collateral”);

**WHEREAS**, the Trademark Security Interest was recorded with the United States Patent and Trademark Office on October 2, 2017 at Reel 6168 Frame 0428; and

**WHEREAS**, the Agent wishes to release and restore all of its right, title and interest in and to the Specified Trademark Collateral to the Grantor.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent, on behalf of the Secured Parties, hereby terminates, cancels and releases any and all security interests or liens it (or any Secured Party) has against the Specified Trademark Collateral, and grants, assigns and conveys, without recourse or warranty (express or implied), to the Grantor any and all rights, title and interest it (or any Secured Party) may have in or to the Specified Trademark Collateral.
