ASSIGNMENT OF SECURITY INTEREST IN TRADEMARK COLLATERAL

THIS ASSIGNMENT OF SECURITY INTEREST IN TRADEMARK COLLATERAL (“Assignment”), dated as of October 30, 2020 by Credit Suisse AG, Cayman Islands Branch (the “Assignor”), for the benefit of Cerberus Business Finance Agency, LLC, a Delaware limited liability company (the “Assignee”).

RECITALS:

WHEREAS, pursuant to that certain Credit Agreement, dated as of July 13, 2015 (as amended, restated, supplemented, modified or otherwise changed from time to time prior to the date hereof, including all exhibits and schedules thereto, the “Financing Agreement”) by and among Propulsion Acquisition, LLC, a Delaware limited liability company (the “Borrower”), Propulsion Intermediate Holdings, LLC, a Delaware limited liability company (“Holdings”), each lender from time to time party thereto (collectively, the “Lenders” and individually, a “Lender”) and Assignor, the Lenders agreed to make term loans to the Borrower and its affiliates from time to time pursuant to the terms and conditions of the Financing Agreement;

WHEREAS, pursuant to the Financing Agreement, Belcan, LLC (f/k/a Belcan Corporation), an Ohio limited liability company (the “Grantor”), was required to execute and deliver to Assignor, for the benefit of the Lenders, that certain Grant of Security Interest in United States Trademarks, dated as of July 13, 2015 (the “Trademark Security Agreement”), in favor of Assignor, which was recorded at the United States Patent and Trademark Office on July 14, 2015 at Reel/Frame No. 5576/268; and

WHEREAS, pursuant to the Trademark Security Agreement and the Security Agreement (as defined in the Trademark Security Agreement), Grantor created a continuing security interest in favor of Assignor, for the benefit of the Secured Creditors (as defined in the Security Agreement), in all of Grantor’s right, title and interest in, to and under the Marks (as defined in the Trademark Security Agreement), all Proceeds (as defined in the Security Agreement) and products of the Marks, the goodwill of the businesses with which the Marks are associated and all causes of action for infringement of the Marks or unfair competition regarding the same, as specified in the Trademark Security Agreement, to secure the payment of the Obligations (as defined in the Security Agreement), including without limitation the Marks set forth on Schedule I hereto (such security interest, the “Assigned Interest”).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor, without recourse, representation or warranty, does hereby convey, sell, assign, transfer and set over unto Assignee all of its right, title and interest in, to and under the Assigned Interest.


