**CERTIFICATE OF AMENDMENT  
TO  
AMENDED AND RESTATED  
CERTIFICATE OF INCORPORATION OF  
TIMBUKTU LABS, INC.**

(Pursuant to Section 242 of the  
General Corporation Law of the State of Delaware)

Timbuktu Labs, Inc., a corporation organized and existing under and by virtue of the provisions of the General Corporation Law of the State of Delaware (the “**General Corporation Law**”),

**DOES HEREBY CERTIFY:**

1. That the name of this corporation is Timbuktu Labs, Inc. and that this corporation was originally incorporated pursuant to the General Corporation Law on April 24, 2012 under the name Timbuktu Labs, Inc.

2. That the Board of Directors of this corporation (the “**Board of Directors**”) adopted resolutions amending the Amended and Restated Certificate of Incorporation of this corporation (the “**Restated Certificate**”) as follows:

Article FIRST of the Restated Certificate is hereby amended and restated to read in its entirety as follows:

“**FIRST:** The name of this corporation is Rebel Girls, Inc. (the “**Corporation**”).”

The first sentence of Article FOURTH of the Restated Certificate is hereby amended and restated to read in its entirety as follows:

“The total number of shares of all classes of stock which the Corporation shall have authority to issue is (i) 16,588,220 shares of Common Stock, \$0.001 par value per share (“**Common Stock**”) and (ii) 6,049,506 shares of Preferred Stock, \$0.001 par value per share (“**Preferred Stock**”).”

The first sentence of Article FOURTH, Section B of the Restated Certificate is hereby amended and restated to read in its entirety as follows:

“6,049,506 shares of the authorized and unissued Preferred Stock of the Corporation are hereby designated “**Series Seed Preferred Stock**”, with the following rights, preferences, powers, privileges and restrictions, qualifications and limitations.”

3. All other provisions of the Restated Certificate shall remain in full force and effect.

4. This Certificate of Amendment has been duly approved by the Board of Directors of this corporation in accordance with the provisions of Sections 141 and 242 of the General Corporation Law.

5. Thereafter, pursuant to a resolution adopted by the Board of Directors, this Certificate of Amendment was submitted to the stockholders of this corporation for their approval and

adoption in accordance with the provisions of Sections 228 and 242 of the General Corporation Law and so approved and adopted.
