TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this “**Termination**”), is dated as of October 28, 2020, and made by CIT BANK, N.A. (formerly known as ONEWEST BANK, FSB), as administrative agent on behalf of certain Lenders (the “**Administrative Agent**”) in favor of TRIAD CATALOG CO., L.L.C., a Missouri limited liability company (the “**Grantor**”).

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of August 2, 2012, made by Grantor in favor of the Administrative Agent (the “**Security Agreement**”), a security interest was granted by the Grantor to Administrative Agent in certain collateral (the “**Trademark Collateral**”), including certain trademarks set forth on Schedule I to the Security Agreement;

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office as described on Schedule A; and

WHEREAS, Administrative Agent now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Administrative Agent hereby states as follows:

1. Release of Security Interest. Administrative Agent hereby terminates the Security Agreement and terminates, releases and discharges the entirety of any and all liens or security interests that it may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the Security Agreement, in the Trademark Collateral, including the trademarks listed on Schedule A hereto, and reassigns, transfers and conveys to the applicable Grantor, without recourse, representation or warranty, express or implied, written or oral, by Lender of any kind, all right, title and interest of Administrative Agent in the Trademark Collateral, and any right, title or interest of Administrative Agent in such Trademark Collateral shall hereby terminate, cease and become void.

2. Filing. Administrative Agent hereby authorizes and consents that this termination may be filed and recorded by Grantor or its designee in the United States Patent and Trademark Office.


