TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS is made as of October 2, 2020 in favor Wellevate LLC (“Grantor”) by Madison Capital Funding LLC, (“Agent”). Capitalized terms not defined herein shall have the meanings ascribed to them in the Trademark Security Agreement (as defined below).

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of June 30, 2016, by and among Grantor and the Agent (the “Trademark Security Agreement”), Grantor created and granted to Agent, for the benefit of the Lenders and its successors and assigns, a security interest in and lien on all of such Grantor’s right, title and interest in and to the Collateral of such Grantor, including the Intellectual Property of such Grantor set forth on Schedule I hereto (collectively, the “IP Collateral”);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 8, 2016 at Reel/Frame 5831/0346;



NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates the Trademark Security Agreement and hereby terminates, cancels and releases its security interest in and lien on the IP Collateral, and reassigns to each Grantor any right, title or interest it may have in the IP Collateral of such Grantor
