FIRST SUPPLEMENT TO AMENDED AND RESTATED
TRADEMARK SECURITY AGREEMENT

This First Supplement to Amended and Restated Trademark Security Agreement (this "Supplement") is made as of the 3rd day of November, 2020 by **AUTHENTIX, INC.**, a Delaware corporation ("Grantor"), in favor of **SILICON VALLEY BANK** (the "Assignee").

WHEREAS, the Grantor executed and delivered an Amended and Restated Trademark Security Agreement dated April 20, 2020 and recorded with the United States Patent and Trademark Office (the "USPTO") on April 20, 2020 at Reel 6919, Frame 0456 (the "Grant") in favor of the Assignee, pursuant to which the Grantor pledged, assigned and granted a security interest in certain Trademarks (as defined therein);

WHEREAS, the Grantor has acquired additional Trademarks and desires to hereby confirm the pledge of, and the grant of a security interest in, the additional Trademarks in favor of the Assignee.

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:

1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Grant.
2. Supplement to Schedule A. Schedule A to the Grant is hereby supplemented, but not replaced, by Schedule A-1 annexed hereto.
3. Miscellaneous:
 - a. Except as provided herein, all terms and conditions of the Grant remain in full force and effect. The Grantor hereby ratifies, confirms and reaffirms all of the representations, warranties and covenants contained therein.
 - b. This Supplement and the Grant cover the entire understanding of the parties with respect to the matters set forth herein and supersede all prior discussions and negotiations hereon.


