This Release of Security Interest in Trademarks (this "**Release**") is intended to operate as a release of all liens and security interests conveyed by Assignee to Agent pursuant to the terms of the IP Security Agreement, and to reassign to Assignee all of Agent's right, title, and interest acquired pursuant to the terms of such IP Security Agreement.
