**TERMINATION AND RELEASE OF  
TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (“Release”) is made as of this 2<sup>nd</sup> day of November, 2020, by ARROWMARK AGENCY SERVICES LLC, a Delaware limited liability company, in its capacity as agent (“Agent”), in favor of ZIPPY SHELL INCORPORATED, a Delaware corporation, (“Grantor”).

WHEREAS, Grantor entered into a certain Trademark Security Agreement, dated June 4, 2018 with Agent, notice of which was recorded with the United States Patent and Trademark Office on June 5, 2018 at reel/frame 6344/0447 (the “Trademark Security Agreement”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted to Agent, under the terms of the Trademark Security Agreement, a Security Interest in favor of Agent, in and to all of their right, title and interest in and to the Trademark Collateral, including without limitation the Trademarks listed in Schedule I.

WHEREAS, Agent has agreed to terminate and release its Security Interest in all such Trademark Collateral as herein provided.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent hereby releases, terminates and discharges its Security Interest in the Trademark Collateral, including the Trademarks listed on Schedule I attached hereto and made a part hereof, and assigns, transfers and conveys to Grantor any interest in such Trademarks, including the Security Interest.
