RELEASE OF TRADEMARK SECURITY INTEREST

This Release of Security Interest Agreement (“Release”) made by Wells Fargo Bank, National Association, a national banking association with an address at 300 Barr Harbor Drive, Conshohocken, Pennsylvania 19428 (“Secured Party”) to Mariner Seafood Marketing, Inc., a Massachusetts corporation with an address at 86 MacArthur Drive, New Bedford, Massachusetts 02743 and Mariner Seafood, LLC, a Massachusetts corporation with an address at 86 MacArthur Drive, New Bedford, Massachusetts 02743 (together, “Debtors” and each a “Debtor”).

WHEREAS, Secured Party is the holder of a Trademark Collateral Agreement dated May 24, 2018 (the “Security Interest”), in which Debtors conveyed to Secured Party a security interest in the right, title and interest in and to certain trademarks, trademark registrations, and trademark applications of the Debtors, listed on Exhibit A hereto, and all of the goodwill of the business connected with the use of and symbolized by, each such trademark, trademark registration and trademark application, and all extensions and renewals thereof (collectively, the “Collateral”), which was recorded with the U.S. Patent and Trademark Office at microfilm Reel/Frame Number 6417/0258 (as to U.S. Reg. Nos. 3941965 and 5927157 and U.S. Application Serial No. 87/865,964) and at microfilm Reel/Frame Number 6417/0366 (as to U.S. Reg. No. 5,385,906), on July 12, 2018.

WHEREAS, Secured Party desires to terminate and release the Security Interest in the Collateral in favor of Debtors;

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured

Party hereby relinquishes, releases, and discharges the continuing Security Interest in and lien on the Collateral, nunc pro tunc as of October 26, 2020, and assigns, grants, and conveys to Debtors, any and all rights, title and interest Secured Party may have in or to the Collateral, and any right, title, and interest of the Secured Party in the Collateral shall hereby cease and terminate.

Secured Party hereby represents and warrants that it has not assigned any interest in the Collateral and has the unqualified right to enter into this release and perform its terms.
