RELEASE OF SECURITY INTEREST
IN PATENTS AND TRADEMARKS
(SECOND LIEN)

This RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS (this “**Release**”), dated as of November 3, 2020 (the “**Effective Date**”), is made by CORTLAND CAPITAL MARKET SERVICES LLC, a Delaware limited liability company having an office at 225 W. Washington St., 9th Floor, Chicago, IL 60606, in its capacity as administrative agent and collateral agent for certain Lenders pursuant to the Second Lien Credit Agreement (in such capacity the “**Collateral Agent**”), in favor of DELUXE 3D LLC, a Delaware limited liability company, having an office at 2400 West Empire Avenue, Burbank, CA 91504, COMPANY 3 / METHOD INC. (F/K/A DELUXE CREATIVE SERVICES INC, AND/OR DELUXE MEDIA CREATIVE SERVICES INC.), a Delaware corporation, having an office at 2400 West Empire Avenue, Burbank, CA 91504, and DELUXE LABORATORIES LLC, a Delaware limited liability company having an office at 2400 West Empire Avenue, Burbank, CA 91504 (each a “**Grantor**” and collectively, the “**Grantors**”).

WHEREAS, DELUXE ENTERTAINMENT SERVICES INC., a Delaware corporation (the “**Borrower**”), DESG INTERMEDIATE II INC., a Delaware corporation (“**Holdings**”), Cortland Capital Market Services LLC, as Administrative Agent, the Collateral Agent and the Lenders party thereto entered into that certain Second Lien Credit Agreement dated as of November 6, 2019 (as amended, restated, amended and restated, supplemented, and/or otherwise modified from time to time, the “**Second Lien Credit Agreement**”);

WHEREAS, the Grantors, as Affiliates of the Borrower and beneficiaries of the extension of credit to the Borrower pursuant to the Second Lien Credit Agreement, agreed to enter into and did enter into that certain Second Lien Guarantee and Collateral Agreement dated as of November 6, 2019 (as amended, restated, amended and restated, supplemented and/or otherwise modified from time to time, the “**Second Lien Guarantee and Collateral Agreement**”);

WHEREAS, pursuant to the Second Lien Guarantee and Collateral Agreement, the Grantors entered into that certain Second Lien Patent and Trademark Security Agreement dated as of November 6, 2019 (the “**Security Agreement**”) in favor of the Collateral Agent, pursuant to which each Grantor granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in all of such Grantor’s right, title and interest in and to the Patent and Trademark Collateral including (i) those patents and patent applications listed on Schedule A attached hereto (the “**Released Patents**”) and (ii) those trademarks and/or trademark applications listed on Schedule B attached hereto (the “**Released Trademarks**” and, together with the Released Patents, the “**Released Collateral**”);

WHEREAS, the Security Agreement was duly recorded with the United States Patent and Trademark Office (the “**PTO**”) on November 13, 2019, at Reel 050994, Frame 0428 for patents and patent applications and at Reel 6795, Frame 0001 for trademarks and trademark applications; and

WHEREAS, the Collateral Agent now desires to terminate and release the entirety of its security interest in the Released Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Second Lien Credit Agreement, Second Lien Guarantee and Collateral Agreement or the Security Agreement, as applicable.

2. Release. The Collateral Agent hereby fully terminates, cancels, releases and discharges any and all security interest in and to the Released Collateral arising under the Second Lien Guarantee Collateral Agreement and

the Security Agreement. If and to the extent that the Collateral Agent has acquired any right, title or interest in and to any Released Collateral, the Collateral Agent hereby transfers, conveys and assigns, without recourse, representation or warranty of any kind, such right, title or interest to the applicable owner as indicated on Schedule A or Schedule B attached hereto.

3. Authorization. The Collateral Agent hereby authorizes and requests the Commissioner of Patents and the Commissioner of Trademarks to record this Release of Security Interest in Patents and Trademarks in the United States Patent and Trademark Office with regard to the Security Agreement, Released Patents and Released Trademarks.

4. Further Assurances. The Collateral Agent hereby agrees, at the Grantors' sole cost and expense, to duly execute, acknowledge, procure and deliver any further documents (in form and substance reasonably satisfactory to the Collateral Agent) and do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby.
