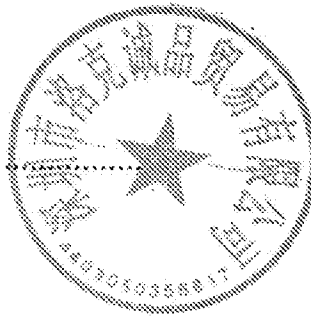
Trademark assignment
