**TRADEMARK ASSIGNMENT**

(e) the right to prosecute, maintain and defend the Transferred Marks before any public or private agency, office or registrar including by filing renewals and all other applications relating to the Transferred Marks.

2. Recordation. Assignor hereby authorizes the Director of Patents and Trademarks in the United States Patent and Trademark Office, and the corresponding entities or agencies in any applicable foreign countries or multinational authorities, to record Assignee as the assignee and owner of the Transferred Marks.


3. Governing Law. Any questions, claims, disputes, remedies or actions arising from or related to this Assignment, and any relief or remedies sought by any parties hereunder, shall be governed exclusively by the laws of the State of Delaware, without regard to any conflict of laws provisions thereof that would result in the application of the laws of another jurisdiction.

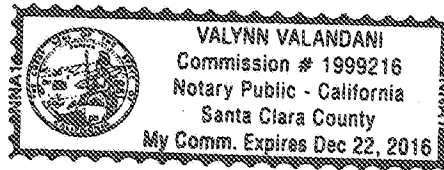
