DEED OF ASSIGNMENT
of certain rights in the trade marks relating to
SPYSCAPE

THIS DEED is made on

26 OCTOBER 2020

BETWEEN

- (1) **ARCHIMEDIA JH HOLDING CORPORATION** incorporated and registered in the British Virgin Islands whose registered office is Flemming House, Wickhams Cay, P.O. Box 662 Road Town, BVI VG1110 (Assignor); and
- (2) **SPYSCAPE LIMITED** incorporated and registered in England and Wales with company number 10296562 whose registered office is at 95 Promenade, Cheltenham UK GL50 1HH (Assignee).

WHEREAS

- (A) The Assignor is the proprietor of trade mark registrations and applications for the Trade Marks (as defined below).
- (B) The Assignee is acquiring the entire business or portion thereof to which the Trade Marks pertain.
- (C) The Assignor has agreed to assign all right, title and interest in and to the Trade Marks to the Assignee, and Assignee has agreed to accept such assignment on the terms set out in this Deed.

NOW THIS DEED WITNESSES as follows:

1. **Definitions**

In this Deed the following expressions shall have the following meanings:

Trade Marks shall mean the registered trade marks and applications which are set out in the Schedule below.

2. **Assignment**

The Assignor hereby assigns, transfers and conveys to the Assignee, absolutely with full title guarantee, all the Assignor's rights and interests in and to the Trade Marks, together with all common law rights with respect to the Trade Marks and all accrued goodwill associated with or symbolised by the Trade Marks. This assignment includes any and all rights, benefits and causes of action in respect to the Trade Marks, including but not limited to the right to sue and recover damages for past, present and future infringement of the Trade Marks and the right to bring or participate in any proceeding before any competent trade mark office or court in any territory in connection with the Trade Marks.

The rights, titles and interests assigned herein are to be held and enjoyed by Assignee and its successors and assigns as fully and as exclusively as they would have been held and enjoyed by Assignor had this assignment not been made.

The consideration amount will be the amount set out in Schedule 2.

3. Further Assistance

The Assignor shall at the Assignee's expense and request do all acts and execute all documents which may be reasonably necessary to confirm the Assignee's title to the Trade Marks and enable the Assignee to become registered as the proprietor of the Trade Marks.

4. Law

This Deed shall be governed by the laws of England and Wales and both parties agree to submit to the jurisdiction of the courts of England and Wales.
