**ASSIGNMENT OF
SECURITY INTEREST IN TRADEMARKS**

This ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS (the “Assignment”) dated as of November 6, 2020, is made by MORGAN STANLEY SENIOR FUNDING, INC., as assignor (the “Assignor”) in favor of CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, as assignee (the “Assignee”). Capitalized terms used but not defined herein shall have the meanings given to them in the Trademark Security Agreement (as defined below) unless otherwise specified herein.

WHEREAS, pursuant to that certain Security Agreement, dated as of August 3, 2011, by and among Academy, Ltd. (the “Grantor”), certain other grantors, and the Assignor, as Collateral Agent, (together with all amendments and modifications, if any, from time to time thereafter made thereto, the “Security Agreement”), the Grantor executed and delivered a Grant of Security Interest in Trademarks Rights, dated August 3, 2011, in favor of the Assignor (the “Trademark Security Agreement”), which was recorded in the United States Patent and Trademark Office on August 3, 2011 at Reel/Frame 4596/0859;

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, Grantor granted to the Assignor (as Collateral Agent), a lien on and security interest (the “Security Interest”) in all of Grantor’s right title and interest in, to and under the Trademarks that were not Excluded Property (including, without limitation, those items listed on Schedule A hereto), including the goodwill associated with such Trademarks and the right to receive all Proceeds therefrom (the “Collateral”);

WHEREAS, pursuant to that certain Resignation and Appointment Agreement, dated November 6, 2020, by and among Assignor, Assignee, the Grantor, and the other grantors party thereto, effective as of the Effective Date, (i) Assignor resigned as Collateral Agent and Assignee was appointed the successor Collateral Agent, (ii) Assignor transferred, assigned, granted and conveyed unto assigned to Assignee, as Collateral Agent, all of its right, title and interest in and to the Security Agreement, the Trademark Security Agreement, and the Security Interest in the Collateral; and

WHEREAS, Assignor and Assignee wish to confirm and record the assignment of the Trademark Security Agreement and the Security Interest in the Collateral by Assignor to Assignee.






