

ARTICLES OF MERGER

FOR

NICOPURE LABS, LLC

The following Articles of Merger are submitted to merge two New Jersey limited liability companies into Nicopure Labs, LLC, a Florida limited liability company, in accordance with Florida Chapter 605.1825, Florida Statutes, and Sections 42:2C-74 through 77 of the New Jersey Revised Uniform Limited Liability Company Act. Nicopure Labs, LLC, a Florida limited liability company, shall be the surviving entity after the merger set forth herein.

The exact name of the merging parties are as follows:

1. Trident Group, Limited Liability Company, a New Jersey limited liability company, having a business identification number of 0400313032 (Merged Entity);
2. Nicopure Labs Limited Liability Company, a New Jersey limited liability company, having a business identification number of 0400378118 (Merged Entity);
3. Nicopure Labs, LLC, a Florida limited company, having a business identification number of L14000118275 (Surviving Entity).
