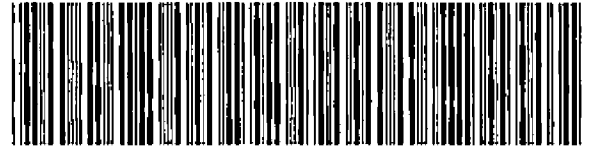

The undersigned officers of Anchor Commercial Bank, Juno Beach, Florida do hereby certify that the Board of Directors of said financial institution approved and proposed to the shareholders thereof, amendment to Article I of the Articles of Incorporation as set out herein, and that thereafter on the 11th day of April, A.D. 2017, at a regular meeting of the shareholders called and held in compliance with Section 607.1006, Florida Statutes, and with the Articles of Incorporation and bylaws of said corporation at its office in Palm Beach Gardens, Florida, at which meeting the holders of a majority of the outstanding capital stock were present. There are three classes of voting stock, and a majority, which was sufficient for approval, approved the amendment changing the name of the corporation to ANCHOR BANK and amending Article I of the Articles of Incorporation so that effective February 14, 2019, in lieu of its present language it shall read:

ARTICLE I

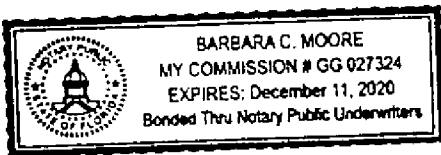

**ARTICLES OF AMENDMENT
TO
AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF
ANCHOR COMMERCIAL BANK**

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, **ANCHOR COMMERCIAL BANK**, a banking corporation organized and existing under the laws of the State of Florida (the "Bank"), hereby amends its Amended and Restated Articles of Incorporation in the manner set forth below in these Articles of Amendment:

FIRST: Article I of the Bank's Amended and Restated Articles of Incorporation shall be replaced in its entirety and shall read as follows:

ARTICLE I

The name of the Bank shall be ANCHOR BANK and its place of business shall be at 11025 RCA Center Drive, Suite 100, in the City of Palm Beach Gardens, in the County of Palm Beach, and in the State of Florida.

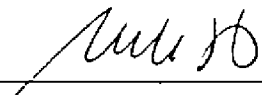
SECOND: Except as hereby expressly amended, the Amended and Restated Articles of Incorporation of the Bank shall remain the same in all respects.

THIRD: These Articles of Amendment contain an amendment to the Bank's Amended and Restated Articles of Incorporation requiring shareholder approval and the shareholders of the Bank, by a resolution adopted at a shareholders meeting held on April 11, 2017, cast a number of votes sufficient for the approval of these Articles of Amendment. Furthermore, the Board of Directors of the Bank, by resolution duly adopted, unanimously approved these Articles of Amendment.

FOURTH: This Amendment shall become effective on the date that these Articles of Amendment are filed with the Department of State of the State of Florida.
