TRADEMARK ASSIGNMENT

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby sell and assign until Assignee, nunc pro tunc, effective as of November 1, 2020, all right, title and interest in and to the Mark, together with the goodwill of the business symbolized by the Mark, and the registration thereof, rights based in common law or the laws of the various states, along with that portion of the on-going and existing business to which the Mark pertains, and all rights to damages and profits due or accrued, arising out of past infringements of said Mark, including, without limitation license royalties and proceeds of infringement suits, and the right to sue for and recover the same.
