## **FULL RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS FULL RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”) is given by PNC BANK, NATIONAL ASSOCIATION, AS AGENT (“**ASSIGNOR**”), to COLORADO BOXED BEEF CO., INTERNATIONAL, INC., a Florida corporation (predecessor in interest to CBBC OPCO, LLC, a Delaware limited liability company) (“**ASSIGNEE**”).

WHEREAS, Assignor and Assignee are party to a Memorandum and Notice of Security Interest in Intellectual Property dated June 29, 2017, recorded on July 7, 2017, at Reel No. 6101 and Frame 0236, at the United States Patent and Trademark Office (as at any time amended, collectively the “**IP Security Agreement**”) memorializing the security interest granted by Assignee to Assignor in and to all of Assignee’s right, title and interest in and to: (a) the Trademarks (as that term is defined in the IP Security Agreement), together with the goodwill and assets of the business, (b) the Patents (as that term is defined in the IP Security Agreement), and (c) the Copyrights (as that term is defined in the IP Security Agreement), and all actions for infringement concerning each of the foregoing (the “**Security Interest**”) pursuant to that certain Revolving Credit and Security Agreement dated as of June 29, 2017 among the Assignor and Assignee.

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Assignor hereby terminates, releases and discharges its Security Interest in and to the Trademarks (as that term is defined in the IP Security Agreement), including, but not limited to, those listed on Schedule A attached hereto, together with the goodwill and assets of the business, and any right, title or interest of Assignor in same shall hereby cease and become void.


