This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of October 14, 2020 ("Release"), is made by **WELLS FARGO BANK, NATIONAL ASSOCIATION** ("Bank"), in favor of **S. MARTINELLI & COMPANY**, a California corporation ("Grantor").

WHEREAS, pursuant to that certain Security Agreement: Business Assets dated as of November 9, 2017, executed by Bank and Grantor (the "Agreement"), Grantor granted and conveyed to Bank a security interest in the entire right, title and interest of Grantor in and to all of Grantor's Trademarks and Copyrights;

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Bank agrees as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Agreement, as applicable.

SECTION 2. Termination and Release. Bank, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the entire right, title, and interest of Grantor in and to all of Grantor's Copyrights listed on Schedule A attached hereto, granted pursuant to the Agreement, and recorded with the U.S. Copyright Office at Volume 9972, Document 178 on October 11, 2019;

(b) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the entire right, title, and interest of Grantor in and to all of Grantor's Trademarks listed on Schedule B attached hereto, granted pursuant to the Agreement, and recorded with the USPTO at Reel 6768, Frame 0775 on October 10, 2019; and


(c) authorizes the recordation of this Release with the USPTO and U.S. Copyright Office, as applicable, at Grantor's expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of California, without regard to its conflict of laws principles.
