FULL RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS FULL RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”) is given by **PNC BANK, NATIONAL ASSOCIATION, AS AGENT (“ASSIGNOR”)**, to **PFD OPCO, LLC**, a Florida limited liability company (“**ASSIGNEE**”).

WHEREAS, Assignor and Assignee are party to a Memorandum and Notice of Security Interest in Intellectual Property dated May 15, 2019, recorded on May 28, 2019, at Reel No. 6654 and Frame 0439, at the United States Patent and Trademark Office (as at any time amended, collectively the “**IP Security Agreement**”), memorializing the security interest granted by Assignee to Assignor in and to all of Assignee’s right, title and interest in and to: (a) the Trademarks (as that term is defined in the IP Security Agreement), together with the goodwill and assets of the business, (b) the Patents (as that term is defined in the IP Security Agreement), and (c) the Copyrights (as that term is defined in the IP Security Agreement), and all actions for infringement concerning each of the foregoing (the “**Security Interest**”) pursuant to that certain Amended and Restated Revolving Credit and Security Agreement among the Assignor and Assignee dated as of May 14, 2019.

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Assignor hereby terminates, releases and discharges its Security Interest in and to the Trademarks (as that term is defined in the IP Security Agreement), including, but not limited to, those listed on Schedule A attached hereto, together with the goodwill and assets of the business, and any right, title or interest of Assignor in same shall hereby cease and become void.

This Release is intended to operate as a release of all liens and security interests conveyed by Assignee to Assignor pursuant to the terms of the IP Security Agreement, and to reassign to Assignee all of Assignor’s right, title and interest acquired pursuant to the terms of the IP Security Agreement, if any.

Assignor hereby authorizes Assignee and its authorized representatives to record this release with the United States Patent and Trademark Office.

This Release may be executed in one or more counterparts and by different parties hereto in separate counterparts, each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument. Delivery of an executed signature page to this agreement by facsimile or other electronic transmission shall be effective as delivery of a manually signed counterpart of this agreement.
