WHEREAS, Assignor is the owner of all right, title, and interest in and to the U.S. service mark applications set forth on Schedule A;

WHEREAS, the Parties desire to enter into this Assignment to affect the transfer of all right, title, and interest in and to the Marks to Assignee on a worldwide basis, including but not limited to the applications set forth on Schedule A; and

NOW, THEREFORE, for and in consideration of the premises and the mutual promises hereinafter set forth and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. Transfer and Assignment. Assignor hereby transfers and assigns to Assignee all right, title, and interest in and to the Marks on a worldwide basis, including but not limited to the applications set forth on Schedule A, together with the portion of Assignor's business to which the Marks pertains and the goodwill associated therewith, along with the right to recover for damages and profits and other remedies for past infringements of the Marks.


2. Further Documentation and Actions. Assignor hereby agrees to execute and deliver to Assignee any further documents and instruments, and to do any and all further reasonable acts that are deemed necessary by Assignee to vest in Assignee all right, title, and interest in and to the Marks, and to enable such right, title, and interest to be recorded in the USPTO and any other appropriate governmental authority or agency of the United States and internationally.

3. Entire Agreement. This Assignment represents the entire agreement between the Parties regarding the Marks and supersedes any previous agreement or discussion between the Parties.
