RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of November 11, 2020 ("Effective Date") from CLYDESDALE BANK PLC ("Clydesdale"), in favor of JK ASSOCIATES, INC., a Pennsylvania corporation, (the "Grantor") and together with Clydesdale, the "Parties").

WHEREAS, the Parties entered into that certain Trademark Security Agreement, dated as of June 18, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantor has granted to Clydesdale a security interest in all of its right, title and interest in and to certain intellectual property owned by the Grantor including, without limitation, the trademarks and trademark applications described on Schedule A annexed hereto and made a part hereof (the "Collateral"); and

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on June 18, 2014 on Reel 5305 / Frame 0122.

NOW, THEREFORE, without recourse, representation or warranty and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Clydesdale hereby terminates, cancels and releases its security interest in, and reassigns to the Grantor all right, title and interest it may have in, the Collateral, including the Collateral set forth on Schedule A hereto and (i) all goodwill connected with the use thereof and symbolized thereby, (ii) all renewals and extensions thereof, rights to sue or otherwise recover for infringements or other violations thereof, (iii) all rights corresponding to the foregoing throughout the world, and (iv) all Proceeds, products, accessions, rents and profits of any and all of the foregoing, and any right, title or interest of the Clydesdale in such Collateral shall hereby cease and become void.

Clydesdale shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such reasonable cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor and at Grantor's expense on an indemnity basis to more fully and effectively effectuate the purposes of this Release. Clydesdale hereby authorizes and requests that the Commissioner for Patents and Trademarks of the United States Patent and Trademark Office record this Release.


