**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of November 10<sup>th</sup>, 2020, is made by GE Business Financial Services Inc., (f/k/a Merrill Lynch Business Financial Services Inc.) a Delaware corporation (the "Secured Party"), in favor of HB&G Building Products, Inc. a Delaware corporation (the "Grantor").

**WHEREAS**, pursuant to and subject to the terms of that certain Trademark Security Agreement dated as of March 7, 2003, by and between the Grantor and the Secured Party (the "First Agreement") and as amended by that certain Amendment No. 1 to Trademark Security Agreement, dated as of February 17, 2009 (the "First Agreement Amendment") and that certain Trademark Security Agreement dated as of February 1, 2008, by and between the Grantor and the Secured Party (the "Second Agreement") and, together with the First Agreement and the First Agreement Amendment, the "Agreements"), the Grantor granted to the Secured Party a continuing security interest in, and a continuing lien upon, all of the trademarks described on Exhibit A hereto (the "Trademarks"); and

**WHEREAS**, the First Agreement was recorded at the United States Patent and Trademark Office (the "USPTO") on March 21, 2003 at Reel 002696 Frame 0927, the First Agreement Amendment was recorded at the USPTO on February 18, 2009 at Reel 003937 Frame 0575 and the Second Agreement was recorded at the USPTO on February 11, 2009 at Reel 003716 Frame 0836.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party, without representation, warranty, or recourse, hereby terminates, cancels, discharges, and releases its continuing security interest in and continuing lien upon any and all right, title and interest of Grantor in and to the Trademarks that were granted pursuant to the Agreements, including, without limitation, those set forth on Exhibit A hereto.
