RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

This Release of Intellectual Property Security Interest (this “**Release**”) is dated as of October 20, 2020, and entered into by Remington Outdoor Company, Inc., FGI Operating Company, LLC, Barnes Bullets, LLC, Remington Arms Company, LLC, Remington Arms Distribution Company, LLC, FGI Holding Company, LLC, RA Brands, LLC, FGI Finance, Inc., TMRI, Inc., Huntsville Holdings LLC, 32E Productions, LLC, Great Outdoors Holdco, LLC, and Outdoor Services, LLC (collectively, the “**Companies**”) and Ankura Trust Company, LLC as agent under the Term Credit Agreement (as defined below) and the FILO Credit Agreement (as defined below) (in such capacities, respectively, the “**TL Agent**” and the “**FILO Agent**”) for the Secured Parties.

WHEREAS, the Companies are party to that certain Term Loan Agreement, dated as of May 15, 2018 (as further amended), by and among FGI Operating Company, LLC, the Guarantors party thereto from time to time, the TL Agent and the Lenders party thereto (the “**Term Credit Agreement**”).

WHEREAS, the Intellectual Property Security Agreement relating to the Term Credit Agreement was recorded with the United States Patent and Trademark Office on May 21, 2018 at Reel 6333 and Frame 0395.

WHEREAS, the Companies are parties to that certain First Lien Last-Out Term Loan Agreement, dated as of May 15, 2018 (as further amended), by and among FGI Operating Company, LLC, the Guarantors party thereto from time to time, the FILO Agent and the Lenders party thereto (the “**FILO Credit Agreement**”).

WHEREAS, the Intellectual Property Security Agreement relating to the FILO Credit Agreement was recorded with the United States Patent and Trademark Office on May 21, 2018 at Reel 6333 and Frame 0506.

WHEREAS, the parties now desire to terminate and release the security interest in and lien on certain intellectual property collateral as set forth on **Exhibit A** hereto (the “**IP Collateral**”);

WHEREAS, and the Companies entered into a certain Asset Purchase Agreement by and among Sportsman’s Warehouse, Inc. (“**Sportsmans**”), Remington Outdoor Company, Inc. and certain of Remington Outdoor Company, Inc.’s subsidiaries dated as of October 7, 2020 where Sportsmans acquired the IP Collateral free and clear of all claims, liens and encumbrances.

WHEREAS, capitalized terms used herein without definition have the meanings given to them in the IP Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the TL Agent and the FILO Agent does hereby (a) terminate the security interests in and lien on the IP Collateral, (b) discharge and release its security interest in and lien on the IP Collateral, and (c) reassign any and all rights, title and interest it has in the IP Collateral to Sportsmans, whether granted pursuant the Term Credit Agreement, FILO Credit Agreement, or any other agreement or document delivered in connection with Term Credit Agreement or FILO Credit Agreement.
