TRADEMARK ASSIGNMENT

WHEREAS, EyeVerify Inc., a corporation duly organized and existing under the laws of Delaware, and having a place of business at 1740 Main Street, Suite 100, Kansas City, Missouri 64108, United States of America (hereinafter "ASSIGNOR"), holds all right, title and interest in and to the trademarks, service marks and trade names set forth in Schedule A attached hereto (hereinafter collectively "the Marks"); and

1. For good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, ASSIGNOR does hereby sell, assign and transfer unto ASSIGNEE, effective as of 24 September 2020, the entire right, title and interest in and to the Marks, together with the good will of the business in connection with which the Marks are used, the same to be held and enjoyed by ASSIGNEE, its successors, permitted assigns or legal representatives, together with income, royalties, damages or payments due on or after the date hereof, including, without limitation, all claims for damages or payments by reason of infringement or unauthorized use of the Marks, along with the right to sue for past infringements and collect same for ASSIGNEE'S sole use and enjoyment.
2. ASSIGNOR shall do all acts and execute all documents which may be reasonably required by ASSIGNEE in order to effect the assignment of the Marks and to ensure that any and all applications shall proceed in the name of ASSIGNEE and the registrations be granted and/or assigned to ASSIGNEE.
3. ASSIGNEE and ASSIGNOR also agree that multiple copies of this Assignment may be executed, each of which shall be deemed an original, and each of which shall be valid and binding upon ASSIGNEE and ASSIGNOR.
