TRADEMARK ASSIGNMENT



This Assignment shall be governed by and construed in accordance with the laws of the State of North Carolina. This Assignment may be executed in one or more counterparts, each of which shall be considered an original, but all of which taken together shall constitute one and the same instrument.
