SERVICE MARK ASSIGNMENT

THIS SERVICE MARK ASSIGNMENT (“Assignment”), effective as of November 13, 2020 (“Effective Date”), is made and entered into by Chicago Title Company, LLC, a Delaware limited liability company (“Assignor”), in favor of FNF Intellectual Property Holdings, Inc., a Delaware corporation (“Assignee”).

2. Assignor covenants and agrees that it will, at any time, on request, execute and deliver any and all papers that may be necessary or desirable to perfect the title to the aforementioned assets and rights assigned by this Assignment.
