**TRADEMARK ASSIGNMENT**

Assignor authorizes and requests the Commissioner for Trademarks of the United States, and any official of any country or countries foreign to the United States, whose duty it is to issue Trademarks or other evidence or forms of intellectual property protection on Trademarks for such protection, to issue the same to Assignee, its successors, legal representatives, and assigns, in accordance with the terms of this assignment.
