RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of November 12, 2020 (this "Release"), is made by WILMINGTON TRUST, NATIONAL ASSOCIATION, in its capacity as collateral agent (in such capacity, the "Collateral Agent"), in favor of WASTE CONTROL SPECIALISTS LLC, a Delaware limited liability company (the "Grantor"). Capitalized terms used but not otherwise defined herein shall have the meanings set forth in the Intellectual Property Security Agreement (as defined below).

WITNESSETH:

WHEREAS, the Grantor and the Collateral Agent entered into that certain Intellectual Property Security Agreement, dated as of January 26, 2018 (the "Intellectual Property Security Agreement"), pursuant to which the Grantor pledged and granted to the Collateral Agent a security interest in and to all of its right, title and interest in, to and under the Trademarks (as defined therein), including without limitation, the trademark registrations and applications listed on Schedule I hereto;

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on January 29, 2018 at Reel 006259 and Frame 0348; and

WHEREAS, Grantor has requested and the Collateral Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in and to the Trademarks.


NOW, THEREFORE, in consideration of the premises, and for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the security interests created under the Intellectual Property Security Agreement in the Trademarks, (b) discharge and release its security interest in and to the Trademarks, and (c) reassign any and all rights, title and interest it has in the Trademarks to the Grantor.

THIS RELEASE SHALL BE DEEMED TO BE A CONTRACT UNDER THE LAW OF THE STATE OF NEW YORK WITHOUT REGARD TO ITS CONFLICT OF LAWS PRINCIPLES THAT WOULD REQUIRE THE APPLICATION OF ANY OTHER LAW.
