TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (the "Release") is made as of November 12, 2020 (the "Release Date") by BSP AGENCY, LLC, with principal offices at 9 West 57th Street, Suite 4700, New York, New York 10019 ("Collateral Agent"), for the benefit of NORTHLAND TELECOMMUNICATIONS CORPORATION, a Washington corporation with principal offices at 101 Stewart Street, Seattle, WA 98101 (the "Grantor").

WHEREAS, the Grantor entered into that certain Grant of Security Interest in United States Trademarks, dated as of October 1, 2018 with Collateral Agent (as at any time prior to the date hereof amended, supplemented or otherwise modified, the "Trademark Security Agreement"), pursuant to which Grantor has granted to Collateral Agent a continuing security interest in:

(i) all of the Grantor's right, title and interest in, to and under the United States trademarks, trademark registrations, trademark applications and domain names (the "Marks") set forth on Schedule A attached hereto, (ii) all Proceeds (as such term is defined in that certain Security Agreement among the Grantor, the other grantors from time to time party thereto and the Collateral Agent, dated as of October 1, 2018 (as amended, modified, restated and/or supplemented from time to time, the "Security Agreement")) of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same (clauses (i)-(iv) collectively, the "Trademarks").

WHEREAS, on October 1, 2018, Collateral Agent recorded with the United States Patent and Trademark Office (the "USPTO"), at Reel 006466, Frame 0795, notices of security interests in the Trademarks; and

WHEREAS, all outstanding amounts owed under any financing documents executed in connection with the Security Agreement have been satisfied and the Grantor has requested that Collateral Agent release its security interest in the Trademarks.

NOW THEREFORE, in consideration thereof and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent agrees as follows:

1. Release of Security Interest. Effective as of the Release Date, Collateral Agent hereby irrevocably and forever terminates the Trademark Security Agreement and terminates, releases and discharges the entirety of the security interest and continuing lien on the Trademarks.
2. Recordation of Release. Collateral Agent understands and agrees that this Release may be recorded by or for the Grantor with the USPTO at the Grantor's sole cost and expense.
3. Further Actions. Collateral Agent further agrees to execute any other documents and take any further action reasonably necessary in any state, country or jurisdiction that the Grantor may reasonably require to effect the intent and purpose of this Release, provided that all

such documents are to be prepared by counsel to the Grantor and the cost and expense of such documents and actions shall be borne solely by the Grantor.


4. Capitalized Terms. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Security Agreement, as applicable.
