**TERMINATION OF SECURITY INTEREST

**THIS TERMINATION OF SECURITY INTEREST IN TRADEMARKS** dated as of November 12, 2020 (this "Termination") is made by **KEYBANK NATIONAL ASSOCIATION**, as Administrative Agent (together with its successors and assigns, the "Grantee") under that certain Intellectual Property Security Agreement dated September 6, 2019 (as amended, restated or otherwise modified from time to time, the "Grant") in favor of **NORTHSTAR DEMOLITION AND REMEDIATION, LP**, a Delaware limited partnership and **NORTHSTAR CG, LP**, a Delaware limited partnership (collectively, the "Grantors").

**NOW, THEREFORE**, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Grantee hereby unconditionally and expressly releases, terminates and discharges, without any representation, recourse or undertaking of any kind, any and all of its right, title and interest in and to any and all liens on and security interests it may have upon the Released Collateral.

The Grantee consents and agrees to execute and deliver, at the request and cost of each Grantor, such further instruments, documents and release forms as each Grantor may reasonably request to more effectively release, terminate and discharge any such liens and security interests upon such Released Collateral.


