**FIRST CERTIFICATE OF AMENDMENT OF
CERTIFICATE OF INCORPORATION
OF C.I.O.N., INC.**

Article FIRST of the Certificate of Incorporation hereby is deleted in its entirety and the following substituted in lieu thereof:

3.
