
AND WHEREAS, the Parties wish to ratify and confirm such assignment in a writing suitable for recordation with the United States Patent and Trademark Office;

IN TESTIMONY WHEREOF, ASSIGNOR and ASSIGNEE have executed this Assignment by their duly authorized officers.


