The Agent hereby authorizes the recordation of this Release with the United States Patent and Trademark Office and/or any other applicable governmental office or agency. The Agent agrees to execute and deliver to the Grantor, at the Grantor’s expense, all other instruments and other documents as may be reasonably necessary or proper to release the security interest in the Trademarks which had been granted under the Trademark Security Agreement or Security Agreement.
