IP SUPPLEMENT

This IP SUPPLEMENT, dated as of November 17, 2020, is delivered pursuant to and supplements, but does not replace, (i) the Security Agreement dated as of December 19, 2011 (as amended, restated, supplemented, reaffirmed or otherwise modified from time to time, the “**Security Agreement**”), among Producers Rice Mill, Inc., an Arkansas corporation (the “**Grantor**”), the other grantors from time to time party thereto, and CoBank, ACB, a federally chartered instrumentality of the United States, as Secured Party, and (ii) the Grant of Trademark Security Interest dated as of December 19, 2011 (the “**Grant**”) executed by the Grantor in favor of the Secured Party. Capitalized terms used herein and not otherwise defined herein shall have the meanings ascribed thereto in the Security Agreement and the Grant.

The Grantor grants to the Secured Party a security interest in all of the Grantor’s right, title and interest in and to the additional Trademark Collateral set forth on Schedule 1 annexed hereto. All such Trademark Collateral shall be added to and deemed to be part of the Trademark Collateral (as defined in the Grant) and shall be hereafter subject to each of the terms and conditions of the Security Agreement and the Grant.
