**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this “**Release**”), dated as of November 16, 2020, is made by NXT Capital, LLC, as administrative agent for the Secured Parties (the “**Agent**”), under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement or Security Agreement referred to therein).

WHEREAS, GSM Acquisition Holdco, Corp., a Delaware corporation, GSM Acquisition Buyer, Inc., a Delaware corporation, GSM Investment, Inc., a Delaware corporation, GSM Holdings, Inc., a Delaware corporation, Agent (as successor to The Governor and Company of the Bank of Ireland), each Lender from time to time party thereto and each other party thereto have entered into that certain Credit Agreement dated as of June 1, 2018, as amended, amended and restated, supplemented or otherwise modified from time to time (the “**Credit Agreement**”), pursuant to which the Lenders have severally agreed to make Loans and other financial accommodations to the Credit Parties upon the terms and subject to the conditions therein;

WHEREAS, in connection with the Credit Agreement, the Credit Parties have entered into that certain Security Agreement dated as of June 1, 2018 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”);

WHEREAS, in connection with the Credit Agreement and the Security Agreement and pursuant to those certain trademark security agreements and patent security agreements described on Annex I attached hereto (collectively, the “**Intellectual Property Security Agreements**”), certain of the Grantors under the Security Agreement, granted security interests in the intellectual property owned by such Grantors, including that listed on Annex I attached hereto (the “**Intellectual Property Collateral**”); and

WHEREAS, the Intellectual Property Security Agreements were recorded in the United States Patent and Trademark Office (the “**USPTO**”) on the dates and on the reel and frame numbers set forth on Annex I hereto.

NOW THEREFORE, in consideration of the material covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby releases, terminates and discharges, without representation, recourse or warranty whatsoever, all of its rights in, to and under, including its Lien on and security interest in, and right of setoff against, the Intellectual Property Collateral, whether granted pursuant to the Intellectual Property Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and the Agent hereby reassigns any and all such right, title and interest (if any) that the Agent may have in, to and under the Intellectual Property Collateral to the Grantors.

The Agent agrees, at Grantors' expense, to cooperate with Grantors and to provide Grantors with the information and additional authorization reasonably required or desirable to effect the release of the Agent's security interest in the released collateral described herein.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.





