**TRADEMARK ASSIGNMENT**

This ASSIGNMENT OF TRADEMARKS (this “Assignment”) is entered into on October 29, 2020 (the “Effective Date”), between Lumentum Operations LLC, a Delaware limited liability company (“Assignee”), and TriLumina Corp., a Delaware corporation (“Assignor”). This Assignment is being entered into on the Effective Date pursuant to the transactions contemplated by that certain Asset Purchase Agreement made and entered into as of October 29, 2020 by and among Assignee and Assignor (the “Purchase Agreement”). Capitalized terms not defined herein will have the meaning set forth in the Purchase Agreement.

**RECITALS**

WHEREAS, Assignor is the owner of the entire right, title and interest in and to the trademarks, trademark applications set forth in Schedule A attached hereto (collectively, the “Trademarks”) and in the goodwill related thereto, and Assignee wants to acquire the entire right, title and interest in and to the aforesaid Trademarks and the goodwill related thereto.

**AGREEMENT**

In consideration of the mutual covenants contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1. Trademarks. Assignor agrees to and does hereby sell, assign, transfer, grant and convey to Assignee, free and clear of all pledges, security interests, liens, charges, encumbrances, equities, claims, options or limitation of every kind, all of Assignors worldwide right, title and interest in, to and under the Trademarks and the goodwill related thereto, and appoints any officer of Assignee as its duly authorized attorney to execute, file, prosecute and protect the same before any government agency, court or authority, together with the goodwill of the business associated with the Trademarks and which is symbolized by the Trademarks, all rights to sue for infringement of the Trademarks, whether arising on, prior to or subsequent to the date of this Assignment, and any and all registrations, renewals and extensions related to the Trademarks that may hereafter be secured under the laws now or hereafter in effect in the United States and in any other jurisdiction, the same to be held and enjoyed by Assignee, its successors and assigns, from and after the date of this Assignment. The assignment of the Trademarks granted herein includes all rights of action accrued, accruing and to accrue under and by virtue of the Trademark, including all right to sue or otherwise recover for past, present and future infringement and to receive all damages, payments, costs and fees associated therewith.

2. Assignment. This Assignment shall be binding upon the successors and assigns of Assignor and inure to the benefit of the successors and assigns of Assignee.

3. Governing Law. This Assignment shall be construed, interpreted and applied in accordance with the laws of the State of California.
