**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “Release”), dated as of November 12, 2020, is granted by JPMorgan Chase Bank, N.A., a New York banking corporation (successor in interest to The Chase Manhattan Bank) (the “Administrative Agent”), in favor of Radio City Trademarks, LLC and Radio City Productions, Inc. (formerly known as Radio City Music Hall Productions, Inc.) (each a “Grantor”).

WHEREAS, Grantors or their affiliates were parties to (i) that certain Credit Agreement, that certain Credit Party Security Agreement, and that certain Credit Party Pledge Agreement, each dated June 6, 1997, between Madison Square Garden, L.P. (“Parent”), the Administrative Agent, (ii) that certain Subsidiary Guaranty, dated June 6, 1997, executed by among other parties, certain subsidiaries of Parent, and (iii) that certain Additional Collateral Agreement, dated February 3, 1998, between Grantors, Administrative Agent and other parties, and recorded with the U.S. Patent and Trademark Office on May 21, 1998 at Reel / Frame 1730 / 0009 (the “Additional Collateral Agreement,” and, together with each of the agreements described in clauses (i) and (ii), each as amended, supplemented or otherwise modified, the “Security Agreements”);

WHEREAS, pursuant to the Security Agreements, Grantors granted a security interest in certain collateral constituting intellectual property, including those items listed on Schedule A hereto (together with any goodwill associated with any of the foregoing, the “IP Collateral”); and

WHEREAS, on or about March 8, 2004 (the “Payoff Date”), the indebtedness and obligations of Parent and other credit parties under the Security Agreements were fully paid and discharged, and all security interests and other liens granted to the Administrative Agent in connection with the Security Agreements, including as granted by Grantors with respect to the IP Collateral, were terminated and released.

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the IP Collateral pursuant to the Security Agreements, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Administrative Agent hereby states as follows:

1. Definitions. All capitalized terms used herein that are defined in the Additional Collateral Agreement and that are not otherwise defined herein shall have the respective meanings ascribed to them in the Additional Collateral Agreement.
2. Release of Security Interest. Effective as of the Payoff Date, the Administrative Agent hereby irrevocably terminates, releases and discharges, without representation or warranty of any kind, the entirety of the security interest, liens and other rights in and to the IP Collateral arising in connection with the Security Agreements.
3. Recordation. The Administrative Agent hereby authorizes and requests that the U.S. Patent and Trademark Office note and record the releases and terminations granted under this Release.
4. Governing Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.
