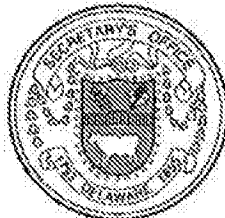

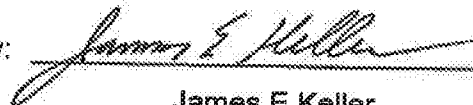
- i. the Certificate of Formation was amended by a Written Consent to Action By the Sole Member of the Company effective as of June 30, 2020 (the "Written Consent"); and
