## TERMINATION OF SECURITY INTEREST IN TRADEMARK

WHEREAS, EOTECH, LLC, a Michigan limited liability company with its principal place of business at 1201 E. Ellsworth Road, Ann Arbor, Michigan 48108 (the "*Registrant*"), is the owner of record of U.S. Trademark Registration No. 2006681 for HOLO SIGHT (the "*Trademark*"); and
