FIFTH: The merger is to become effective at 11:59 p.m. EDT on July 31, 2020.

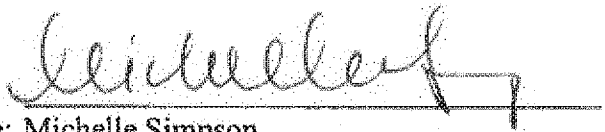
